Here you will get an overview of the measures currently being taken at Schloss Purschenstein in accordance with the latest official regulations and general ordinances in connection with the ongoing Covid 19 pandemic.

The measures taken in this regard always take into account the comfort and well-being of our guests. All of our staff is committed to ensuring your comfort throughout your stay.

Overnight stays are again possible without restrictions in Saxon accommodation facilities. However, if you have flu-like symptoms, please reconsider traveling at this time in the interest of everyone.

If you have any questions about the implemented measures, please do not hesitate to contact us.

Breakfast: During your stay we will serve you a rich breakfast buffet between 7:30 am and 10:30 am.

Restaurant: our restaurant Remise is open for dinner reservations from Wednesday to Sunday between 17:30 and 20:30. Please reserve your table for a specific period in advance at the reception.

Wearing a mask is mandatory when entering or moving around the restaurant, breakfastroom or at the buffet. Once you are at your table, they can be removed, of course.

Wellness area: Our wellness area is open in compliance with the social distancing rules. Please note that there are restrictions on the number of people in this area. Our steam room unfortunately remains closed as per the current regulations.

Public Areas: During the day, one of our staff members will continuously clean and disinfect the public areas and restrooms.

Your Room: Our housekeepers have prepared and carefully disinfected your room. During your stay, you may wish to decline the daily cleaning of your room. If you wish to do so, please inform the front desk. However, the cleaning service will only enter your room when you are not present. Please make sure the green "Clean my Room" sign is on the outside of your door.

In general, we recommend wearing mouth and nose masks when walking through enclosed spaces, as it can sometimes be difficult to maintain the required social

distance in hallways and/or on stairs. On the stairs, it would be good to stay on the right side and make room for those descending the narrower stairs.

Please note that only people from the same household may use the elevator at the same time.

Disinfection dispensers and stations are available throughout the hotel complex in sufficient numbers.

The state of Saxony is guided by the 7-day incidence and accordingly adopts corona restrictions. Please refer to the following website for the current 7-day incidence: https://www.coronavirus.sachsen.de/infektionsfaelle-in-sachsen-4151.html.

The following incidence schedule has been established:

7-day incidence below 35: No restrictions other than distance rules and mask requirement.

7-day incidence above 35: If a county or a county-free city records 35 or more new infections per 100,000 inhabitants in seven days, the so-called 3G rule applies. Then proof of vaccination, recovery or testcertification no older than 48hrs is required upon your arrival.

We expect that the restrictions we have introduced will guarantee our guests an extremely comfortable, safe and pleasant stay with us.
